If the daily amount for a resident is less than \$25 the basic subsidy for the late claim period is \$0.

Where an appraisal or reappraisal is received more than 3 months after the end of the appraisal or reappraisal period, the basic subsidy is \$0 for the late claim period.

**1. Transition Care Subsidy and dementia and veterans' supplement equivalent amount**
